NOTE: Normal wear and tear **does not** include deep scratches, cracks, damage caused by dropping the instrument or due to leaving it in a place where the temperature is above 80 degrees or below 45 degrees. It also does not cover water damage or the use of unapproved cleaning products. Normal wear and tear that **is** included would be worn out strings, loose seams, a few lost bow hairs and other parts that may wear out over time. Strings may break on their own. The director will replace strings at no cost to the renter unless the student is responsible for the broken strings by using the pegs to tune, dropping the instrument, or allowing someone untrained to tamper or play with the instrument.

Students renting a Cello or Bass from Belzer will be required to bring their instrument into the orchestra director at least 2-3 times each month and at least one day prior to a concert day for routine maintenance, and tuning. The instrument will be used at the concert and is to be taken back home the night of the concert. In addition they will have a cello to use at school, free of charge, so they do not have to transport the instrument back and forth on a regular basis.

- I agree to return the instrument to the director upon request at any time prior to the expiration of this contract.**
